### **Minutes:**

Principal & Dean Academics invited all the GB members to this 31<sup>st</sup> GB meeting (Online mode) and provided an overview of the recent activities and achievements of the Institution.

## The following agenda items were discussed and deliberated upon:

### 1. Previous governing body meeting

### a. Confirmation of the minutes

The minutes of previous 30<sup>th</sup> GB meeting circulated earlier, are approved.

### 2. Approvals & reports

### a. Appointments

Staff appointments and resignations since previous meeting were ratified by the GB.

### b. Ratification of Minutes of the Academic Council / Finance / Results Committee / BOS meetings

Minutes of the meetings of previous Academic Council / Finance Committee / Results Committee / Board of Studies are ratified by the Governing Body.

#### c. Accreditations & Affiliations

Members were informed of the following updates with regard to various Accreditation / Affiliation status.

#### **NBA**

- Updates on NBA compliance (EEE & CIV) and NBA Cycle-II (CSE, ECE & Mech) accreditations were presented.
- Accreditation for 5 UG Programs (CSE, ECE, EEE, CIV and Mech) under Tier II is valid up to 30-06-2025, NBA compliance (EEE & CIV) applied and pre-qualifiers (CSE, ECE & Mech) are submitted on 05-06-2025 for the 2<sup>nd</sup> cycle accreditation process.

#### **NAAC**

• Accredited by NAAC with an "A+" Grade valid up to 30-06-2027.

#### **Autonomous status**

• The autonomous status was conferred for 10 years and is valid until the AY 2032-33.

### **Permanent affiliation**

• JNTUK, Kakinada, granted permanent affiliation to SVECW from the academic year 2022-23, which is valid until the AY 2025-26.

### 3. Academic Results & Analysis - Ratification

Members were informed of academic semester results announced so far from the previous GB meeting and the same are ratified.

## • Semester Exam Results & Pass Percentages:

**Discussion:** UG pass rates improved by 2%; PG maintained 92% average. Concerns raised over low scores in core Engineering courses.

**Resolution:** Departments to conduct root-cause analysis and submit remedial plans by 31st July 2025.

#### • Condonation & Detention

**Discussion:** 12% of UG students applied for condonation; detention rate capped at 8%. **Resolution:** Strict adherence to condonation guidelines; detention appeals to be reviewed case-by-case

### • Issue of provisional certificates

Members were informed that approval was granted by the Academic Council during its meeting held on 13<sup>th</sup> June 2025 for issue of Provisional Certificates to all 78 MBA students & 28 M.Tech students (Regular & Supplementary) who have passed and cleared all their subjects and the same are ratified by the Governing Body.

### • AICTE Approvals & Intake Enhancements for AY 2025-26

**Discussion:** No New programs were introduced for upcoming AY 2025-26 and AICTE has approved to enhance Intake of M.Tech in CSE & AI&DS has been increased by 50% from 12 to 18 in each program. Governing Body members were informed of the AICTE grant of Extension of Approval (EOA) for the AY 2025-26; the present intake is as follows:

- ✓ B. Tech 900 without lateral entry + 90 EWS Quota
- ✓ M. Tech -54 + 6 EWS Quota
- ✓ MBA 120 + + 12 EWS Quota
- ✓ BBA -60 + 6 EWS Quota

**Resolution:** Admissions team to publish revised intake brochure and process the admissions as per revised count for the upcoming AY 2025-26.

### • Academic Calendar & Schedule

**Discussion:** Calendar finalized with 90 instructional days per semester, including buffer weeks for exams.

**Resolution:** Calendar approved; to be circulated to all stakeholders.

### • Curriculum Development (B.Tech V & VI Semesters)

**Discussion:** Industry feedback incorporated to add new electives and Minor revisions in core syllabus drafted by JNTUK.

**Resolution:** Revised curriculum approved; BoS to finalize course materials.

#### New Policies and Procedures

**Discussion:** Proposed new policies and changes to existing policies were discussed. **Resolution:** Drafted policies were accepted and ratified.

### 4. Activities & Reports

#### R-23 Syllabus

R23 Syllabus & Course Structure approved by BOS for III & IV B.Tech, M.Tech, BBA & MBA was tabled and the same is ratified by the Governing Body.

R23 Syllabus & Proposed Course Structures to be approved by BOS for V & VI B.Tech was tabled and the same is ratified by the Governing Body.

### Funded Projects

Members were informed of the present status of the on-going, completed, and applied R&D projects in various departments and members have expressed their satisfaction.

Suggestions/Opinions shared by the Governing Body members are as follows:

- GB Chairman congratulated the entire RCE team for securing 3 Prathibha awards and 1st place in the state among private engineering colleges.
- Advised including rank analysis details in the agenda from the next meeting onwards, as top-ranking students are joining the college.
- Regarding the R23 syllabus, recommended to discuss with JNTUK officials to secure approval for the curriculum of V & VI semesters ensuring students have a clear understanding of their four-year academic journey.
- Assured that the Management would fully support future plans, including financial assistance.
- Emphasized the importance of CoEs and training for students in seeking global job opportunities and suggested appointing experienced faculty from industry.
- Recommended creating awareness on cyber security and establishing a dedicated Centre
  of Excellence for Cyber security, given the increasing prevalence of cyber- related issues
  and scams.
- Acknowledged the ongoing research efforts and encouraged faculty to publish their work in reputed journals such as Scopus, SCI, WoS, and IEEE Xplorer.

#### 9. Actionable items of the meeting

- ✓ Admitted students profile to be included in the GB meeting.
- ✓ Get the R23 regulations V & VI year curriculum from JNTUK as soon as possible.
- ✓ Recruitment of Industry experts and start the Centre for Excelelnce.
- ✓ The compliance requirements and documentation must be started from July 2025.
- ✓ Identify core subjects in each program and map them with industry required skills.
- ✓ Conduct more lab experiments beyond the syllabus.
- ✓ Study of best placement & training practices being practiced by MKSSS's Cummins College of Engineering for Women, Pune.
- ✓ Publishing articles by faculty and students together on various competitions.
